**Summer 2024 Pell Grant Review Form**

**Priority deadline: 05/01/24**

Students who attended full-time during the 2023-2024 year and have already received their maximum scheduled Pell award may be eligible for additional Pell Grant funds for the summer, if they are enrolled in a minimum of six hours. Students who attended less than-full-time during the 2023-2024 year could possibly have remaining Pell eligibility from their scheduled Pell award.

Vernon College offers a number of summer sessions in an effort to be responsive to the needs of the student body. The 2024 summer session will end the 2023-2024 academic year. Students interested in receiving federal financial aid for summer must have completed the 2023-2024 Free Application for Federal Student Aid (FAFSA) and have been awarded financial aid by the VC Financial Aid Office.

Summer transient students are not eligible to receive financial aid at Vernon College.
