Regular Meeting BOARD OF TRUSTEES

Vernon College March 30, 2011

The Board of Trustees of Vernon College met on March 30, 2011 at 10:00 a.m. in the Board Room of the *Osborne Administration Building* for a Special Meeting which was followed by the Regular Board Meeting at 11:30 a.m. with the following present: Mr. Gene Heatly, Chairman, Mr. Bob Ferguson, Vice-Chairman, Mr. Norman Brints, Secretary. President's Report/Board Discussion Items:

Dr. Johnston reported on the legislative appropriations update. He also reported the bill to allow students with concealed handgun permits to carry weapons on campus would pass.

Dr. Johnston reported that construction at the baseball field is continuing and plans are coming along on the renovations at Century City Center. Rick Sims met with the different departments for their input.

Dr. Johnston reported that the two-year degree program for Criminal Justice will discontinue due to students finding jobs that didn't require the degree. Classes for criminal justice and the police academy will still continue to be offered.

Dr. Johnston reported he has a meeting with the retention completion task force later today for their ideas for implementing improvement to retention and completion.

Dr. Johnston reported that funding for skills development grants will be cut.

Dr. Johnston reported the 2011 Online Foundation Auction raised a total of \$5,622, which will be matched on a 1:1 basis by the Foundation and used as grants to our College in the Fall of this year.
