Regular Meeting BOARD OF TRUSTEES

Vernon College October 20, 2010

The Board of Trustees of Vernon College met on Wednesday, October 20, 2010 at 11:30 a.m. in the Board Room of the *Osborne Administration Building* with the following present: Mr. Gene Heatly, Chairman, Mr. Norman Brints, Secretary.
