# **BOARD OF TRUSTEES**

Vernon College March 11, 2015

The Board of Trustees of Vernon College met on Wednesday, March 11, 2015 at 11:30 a.m. in the *Board Room* of the *Osborne Administration Building*, Vernon, Texas with the following present: Dr. Todd Smith, Chairman, and Mr. Norman Brints, Vice-Chairman. Chairman Smith called the meeting to order at 11:30 a.m.

### Consent Agenda

Mr. Ferguson made the motion, seconded by Mrs. Spears to approve the Consent Agenda containing the *Minutes of the February 18, 2015 Regular Board Meeting* and the *President's Monthly Travel Expense Report*. The motion carried unanimously.

## Action Item C

Mr. Holt made *motion #1*, seconded by Mrs. Spears to approve the *Proposed Tuition and Fee rates for 2015-2016* as presented by Dr. Johnston:

Mr. Ferguson made *motion* #2, seconded by Mr. Brints to approve to exempt out of district dual credit high school students from institutional service fees and special course fees and these students only be charged tuition of \$95 per semester credit hour beginning the 2015 fall semester. The motion carried unanimously.

## Action Item D

Mr. Holt made the motion, seconded by Mrs. Spears to accept the Resale Bids and Quitclaim Deeds for properties held in trust by the taxing entities located at 1101 Strahan, Vernon, TX for the bid amount of \$700. The motion carried unanimously.

<u>Public Comment</u> – No one was present to make comments.

Board Input/Discussion – No input or questions to discuss.

<u>Legislative Update</u> – Dr. Johnston reported on the House and Senate appropriation bills. He thought the concealed weapon bill would probably prevail and pass. Regarding community college funding, the President stated there might be a slight increase in total funding. As for Vernon College, he does not see losing any state funding but cannot give the Board a number until the session ends. He also discussed his concerns with universities offering little or no cost tuition for dual credit, which makes it difficult for community colleges to compete.

Foundation On-Line Auction Update – Mrs. Christie Lehman reported the Foundation's on-line auction was a success. Payments are still coming in and she will have a number to present at the next meeting. There was good participation from both Vernon and Wichita Falls communities and businesses. Approximately 400 items were in the auction this year. The money raised is matched one to one by the Vernon College Foundation and then awarded to College departments through a mini-grant process.

<u>Student Success Data Fact</u> – Mrs. Harkey presented the data fact: Graduation Persistence and Retention Rate. This compares Vernon College data with other community colleges in Texas that are part of Vernon College's cohort. Most of the information comes from the Texas Higher Education Coordinating Board. The comparison shows an increase that meets the benchmark we have set for *at or above* other small colleges.
