BOARD OF TRUSTEES

Vernon College December 17, 2014

The Board of Trustees of Vernon College met on Wednesday, December 17, 2014 at 11:30 a.m. in the *Board Room* of the *Osborne Administration Building*, Vernon, Texas with the following present: Dr. Todd Smith, Chairman, and Mr. Norman Brints, Vice-Chairman. <u>Annual Continuing Education Enrollment Report</u> – Ms. Shana Munson presented the report reviewing comparison charts for 2012-13 and 2013-14 by program, headcount increase or decrease, and contact hours, for continuing education classes funded by the state and non-funded continuing education classes.

<u>Student Success Data Fact</u> – Mrs. Betsy Harkey presented a screenshot of the Texas Higher Education Coordinating Board (THECB) public website. She noted that much of our data is gathered from this website. Vernon College submits a lot of information to THECB, which is calculated into different factors and shared with our colleagues, other institutions and legislators. We use this important site to update and benchmark

our key performance indicators and accountabilities. We also use the data for grants, marketing and recruiting, and comparisons.

<u>Athletic Scholarship Award Report</u> – Dean Hardin presented the end of semester scholarship awards report for Rodeo, Baseball, Softball and Volleyball. This report shows the amount each used for the fall and the balance for the spring. All of the sports are within their budgets for this time of the year.

Dr. Johnston mentioned he picked up some board information handouts at the Texas Coordinating Board training session in November in Austin for the Board's use.
