#### **Minutes**

- I. Approval of Minutes from 11/3/17 ADA Meeting (Exhibit 1)
  - Judy Ditmore made a motion to approve, and Jim Nordone seconded the motion. All members in attendance voted to approve the minutes as is.
- II. Discuss IDEA and 504 Plans vs. ADA Accommodations in College (Exhibit 2)
  - Deana Lehman discussed the differences between modifications offered in high school and
    accommodations offered in college. She said that students and parents often expect to receive the same
    level of assistance that they have had in the public school system. She sometimes has to tell students that
    records from high school don't provide adequate documentation of a disability. She also pointed out that
    students sometimes expect that accommodations will automatically be in place for them, and we have to
    explain that it is their responsibility to contact our office.

### III. ILOS Update

• Roxie Hill presented an update on the ILOS program that the college is considering purchasing for captioning. She said that ILOS would be the most cost-effective program to use because it in a consortium with Virtual College of Texas. However, it is not as user-friendly as TechSmith Relay, which is another program that she has been researching. She said that TechSmith is easier to edit than ILOS. She said that instructors will need to review videos for accuracy. Helix will continue to be our host until December 2018. Deana Lehman added that we can also use this technology for videos on the Vernon College website.
