

Non-Traditional Education at Vernon College

Credit earned through the methods described in this booklet may be applied toward meeting the requirements of a certificate or an associate degree at Vernon College. Credit is awarded only in areas offered within the current curriculum of the institution and is appropriate only as it relates to the student's educational program. Credit earned by examination may not be used to meet the residence requirement.

An examination may be taken prior to enrolling at Vernon College; however, credit earned will be held in escrow until the student has successfully completed (with a grade of C or better) six (6) semester hours of college level work. Credit earned through non-traditional examinations will not be considered in determining grade point averages. Successful performance on an examination will be recorded on a student's Vernon College transcript as credit (CR). No annotation of an unsuccessful performance on an examination will be made.

Credit by examination awarded to a student to meet Vernon College graduation requirements does not guarantee that such credit will transfer to other institutions. A student should always check with the college they are planning to attend to ensure that credit will be granted.

Advanced Technical Credit

The Advanced Technical Credit (ATC) program gives high school students a chance to receive credit at participating community colleges across Texas for taking certain enhanced technical coursed during high school. For a high school to offer an ATC course to its students, the teacher must meet the ATC teacher requirements, go through ATC training and teach the high school course so that it is enhanced to meet the equivalent college course. ATC courses are only offered in technical or workforce areas. Courses in academic areas such as English or History are not offered as ATC courses.

Articulated Credit

Courses taken in grades 11 and 12 in a secondary school will be awarded credit according to the articulation agreement developed by Vernon College and the secondary school.

Evaluation of Military Experiences

Vernon College uses *A Guide to the Evaluation of Educational Experiences in the Armed Services*, published by the American Council on Education (ACE) as a basis for evaluating training in the armed forces. Information may be obtained in the Office of Admissions and Records.

Credit from Non-Degree Programs/Courses and Professional Certifications

Credit earned in a Vernon College non-degree program/course or through professional certification may be converted to semester credit hours provided the following conditions are met:

- Credit awarded represents collegiate course work relevant to the student's declared major
- The amount of credit awarded is clearly stated and is in accordance with commonly good practice
- The course outcomes and competencies must be equivalent
- The course must have been taught by a qualified faculty member

Students concurrently enrolled in courses taught for both credit and continuing education may convert 50% of their technical course work from continuing education to credit. Conversion must be requested within five (5) years after the last course is completed. No more than four (4) semester ours for a credit certificate of 29 or less hours and no more than eight (8) semester hours for a credit certificate over 30 hours or a degree may be converted to semester hour credit through professional certification. Decisions regarding the awarding of credits will be made by qualified faculty members and approved be the instructional dean. The fee is \$25.00 for each transcribed course.

Standardized Examinations

College Level Examination Program (CLEP)

CLEP is a national testing program administered by the Educational Testing Service. Examinations are given to anyone who wishes to take them. CLEP is a computerized test and is administered in the Testing Center by appointment only. The fee for a CLEP exam is \$100. (CLEP Fee of \$85 payable by credit card and a Vernon College Fee of \$15 payable by check or cash.) Below are the all current CLEP examinations accepted by Vernon College.

Defense Activity for Non-Traditional Support (DANTES)

Excelsior College Examination Program (ECEP)

Excelsior College sponsors the ECEP (formerly Regents College). A minimum stand score (SS) of 45, passing (PF), or letter grade (LG) as reported by ACE will be accepted for granting equivalent course credit. The Educational Service Center on Sheppard Air Force Base provides these tests for military personnel. The College is not an ECEP testing site.

Departmental Challenge Examination

For Vernon College courses that cannot be challenged through standardized examinations, departmental challenge examinations (DCE) may be constructed by the appropriate faculty as students apply to challenge such courses. The examination shall be administered by a faculty member in the department in which the equivalent course is taught. Vernon College reserves the right to determine that some courses are not eligible for a departmental challenge exam.

A course syllabus with learner outcomes will be made available to students applying for any course offering a challenge exam. After examining the course learner outcomes, the student can decide whether he/she should elect to take a challenge exam in the course under considerations. The instructional dean must approve each DCE and must sign the student's "Request to Take A Departmental Challenge Examination" form prior to an examination being given. Forms are available in Student Services at all Vernon College locations. DCEs are not given during the summer semester.

A \$35.00 per semester hour testing fee is charged for each DCE given. There is no refund of the examination fee if the student does not make a minimum grade equivalent of "C" or above.

Grades are reported to the Office of Admissions and Records on the "Departmental Challenge Grade Report" from by the faculty grading the exam. If successful, a grade of credit (CR) will be posted on the student's permanent record and be designated as Credit by Departmental Challenge Examination. The credit will not be used in the computation of the student's grade point average. Students may repeat a DCE only after a six (6) month waiting period.

International Baccalaureate Organization

The International Baccalaureate Organization (IBO) is a college preparatory program recognized for its challenging curriculum. Vernon College values the organization's efforts. In accordance with SB 111, Vernon College will award a minimum of 24 credit hours for receiving the IB Diploma, which requires a minimum score of a 4 on all tests (Standard-Level and Higher-Level). IB Credit without an IB Diploma is awarded only for Higher-Level exams with scores of 5, 6, or 7. Credit is recorded to transcripts after the completion of six hours of VC coursework. Within their first academic year, IB students are responsible for notifying VC admissions of their IB status and scores. Prior to enrollment, all IB students must meet TSI (Texas Success Initiative) guidelines for placement. Credit is awarded as listed below.
