A. Review program outcomes

Lou Cardenas asked Dr. Rivard to review program outcomes. Dr. Rivard provided a separate handout with proposed updates to program outcomes; the changes did not affect the outcomes substantially, rather an edited verbiage to promote clarity and adherence to accrediting agency's standards.

Program outcomes (current)

1. Create a **Safe and Effective Care Environment** - promotes the achievement of client outcomes by providing and directing evidence-based nursing care that enhances the health care delivery setting in order to protect clients and healthcare personnel. Implement Effective Management of Care Techniques – employs and directs evidence-

- based nursing care that enhances the health care delivery setting to protect clients and health care personnel.
- 2. Promote **Safety and Infection Control** implement measures to protect clients and health care personnel from health and environmental hazards.
- 3. Advocate **Health Promotion and Maintenance** provides and directs evidence-based nursing care that incorporates the knowledge of expected growth and development principles, prevention and/or early detection of health problems, and strategies to achieve optimal health.
- 4. Promote and Support **Psychosocial Integrity** provides and directs nursing care that promotes and supports the emotional, mental and social wellbeing of the client experiencing stressful events, as well as clients with acute or chronic mental illness.

1. Approve program outcomes:

After review, Lou asked if there were any suggestions. The only discussion was regarding program outcome number one missing from the last matrix shown. After discussion, Lou asked for a motion to approve the program outcomes as discussed.

Erin Lindsey made a motion to approve.

Andrea Anderle seconded the motion.

The motion passed and the committee approved the program outcomes as presented. Lou then moved on to assessment methods.

B. Assessment methods and results

Lou Cardenas asked Dr. Rivard to review the assessment methods and results.

Successful completion of both RNSG 1110 (Introduction to Community-Based Nursing) and RNSG 2162 (Clinical Community), which comprise the capstone experience, will be required for graduation from the ADN Program. The capstone experience consists of 16 lecture hours with associated coursework and 48 hours of Preceptor clinical experience, which includes completion and submission of all preceptor paperwork, SIMS Lab, Hurst Review and Elevate assignments, two HESI Exit examinations, three RNSG 1110 comprehensive final exams, and required remediation. Successful completion of the capstone experience will be required for graduation from the ADN Program. **To successfully complete RNSG 1110/RNSG 2162, the student must:**

- 1. Successfully complete lecture course requirements (RNSG 1110) including but not limited to the Hurst NCLEX-RN Review and Elevate assignments, three RNSG 1110 comprehensive final exams, and two HESI Exit Examinations.
- 2. Successfully achieve clinical preceptor objectives, including Preceptor clinical experiences and SIMS Lab experiences. Complete and submit all Preceptor paperwork.
- 3. Grading:
 - a. Vernon College Comprehensive Final Exams: 60%

b. HESI Exit Exams: 10%

c. Assignments: 15%

d. Remediation: 15%

- 4. Grading Scale:
 - a. A = 90-100
 - b. B = 84-89
 - c. C = 78-83
 - d. < 78 = F
- 5. Complete remediation as required and according to the Remediation Policy (see appendix).
- 6. Failure of RNSG 2162 in the fall semester will result in dismissal/administrative withdrawal from the ADN Program.
- 7. Failure of RNSG 1110 in the spring semester will require the student to re-enroll in both RNSG 1110 and RNSG 2162 in the summer semester to be eligible for August graduation.
- 8. Students required to enroll in the summer RNSG 1110 course <u>will not</u> be eligible for employment as a Graduate Nurse (GN) and <u>are not</u> eligible to sit for the NCLEX until/unless successful completion of the all course requirements has occurred.
- 9. Students failing RNSG 1110 and/or RNSG 2162 in the summer semester will not be eligible for graduation from the Vernon College ADN Program or licensure as a registered nurse.

Failure to achieve the above criteria results in failure of RNSG 1110 and/or RNSG 2162.

During this time period, the median graduate from the program scored as well as, or better than, 28.1% of the program medians in nation on items related to Basic Care and Comfort, 64.3% on items related to Pharmacologic and Parenteral Therapies, 84.25% on items related to Reduction of Risk Potential, and 22.35% on items related to Physiological

Adaptation.

Results used for curriculum planning and revision

D. Program Specific Accreditation Information and Requirements (if applicable)

Lou Cardenas asked Dr. Rivard to review program specific accreditation.

Credentialing Exam – NCLEX-RN Examination From the Texas BON:

Ongoing approval status is determined biennially by the Board on the basis of information reported or provided in the program's NEPIS and CANEP, NCLEX-RN® examination pass rates, program compliance with this chapter, and other program outcomes. Certificates of Board approval will be mailed to all Board-approved nursing programs biennially in even-numbered years.

- (1) Compliance Audit. Each approved professional nursing education program shall submit a biennial CANEP regarding its compliance with the Board's requirements.
- (2) NCLEX-RN® Pass Rates. The annual NCLEX-RN® examination pass rate for each professional nursing education program is determined by the percentage of first time test-takers who pass the examination during the examination year.
 - (A) A minimum of eighty percent (80%) of first-time NCLEX-RN® candidates is required to achieve a passing score on the NCLEX-RN® examination during the examination year.
 - (B) When the passing score of first-time NCLEX-RN® candidates is less than 80% on the examination during the examination year, the nursing program shall submit a Self-Study Report that evaluates factors that may have contributed to the graduates' performance on the

NCLEX-RN® examination and a description of the corrective measures to be implemented. The report shall comply with Board Education Guideline 3.2.1.a. Writing a Self-Study Report on Evaluation of Factors that Contributed to the Graduates' Performance on the NCLEX-PN® or NCLEX-RN® Examination. Within one year of the submission of the Self-Study Report to the Board, the program shall provide to Board Staff evaluation data on the effectiveness of corrective measures implemented.

ACEN Accreditation:

- The ACEN site visit took place February 20-22, 2024.
- The official Decision Letter is expected October 15, 2024.

After review, Lou moved on to program curriculum.

E. Review program curriculum/courses/degree plans

Lou Cardenas asked Dr. Rivard to review the suggested updates to the program curriculum. Proposed changes to be reviewed include moving Nursing Pathophysiology to first semester, move Intro. to Nursing to prerequisite course and reduce by one credit hour, split Nursing Care of the Childbearing And Child Rearing Family in two to provide better balance between Childbearing and Child Rearing Family content, addition of Prof. Nursing Review & Licensure Prep. course, reducing transition courses to allow time for the review course, and the discussion of initiating an online transition program.


