Dr. Mary Rivard reviewed the following outcomes with the committee.

Rachel Gray asked the faculty member, Dr. Mary Rivard, to explain in more detail the assessment methods and results.

Dr. Mary Rivard reviewed the following information with the committee.

The Capstone Experience (VNSG 1205) includes:

Successful completion of VNSG 1205, NCLEX-PN Review, which comprises the capstone experience. The capstone course consists of 32 lecture hours, which includes the Hurst Review, two HESI Exit examinations, and the Vernon College LVN Program Comprehensive Final Exam (LVNCF). Successful completion of the capstone experience will be required for successful completion of the LVN Program. To successfully complete VNSG 1205, the student must:

- 1. Successfully complete course requirements including the Hurst Review, two HESI Exit examinations, and the LVNCF.
- 2. Achieve a score of 975 or higher on the combined score of the highest HESI Exit Examination and LVNCF.
- 3. Failure of VNSG 1205 will result in dismissal from the LVN Program. Students who are unsuccessful on their first attempt at VNSG 1205 may retake the course in the following

- semester. During the second enrollment, students will be given the opportunity to retake the LVNCF and have three additional attempts (two required) on the HESI Exit Exam to reach a combined score of 975 or better.
- 4. Students failing VNSG 1205 on the second attempt will not be eligible for certificate completion or vocational nurse licensure.

Failure to achieve the above criteria results in the failure of VNSG 1205.

Dr. Mary Rivard read the assessment methods and mentioned that number 3 is now part of the program and is not the current requirement. Students now take the exam and if do not pass the 975 on the first time, will take the course the following Summer Short Semester where they will only focus on the class and exam. She also stated for the students:

Fall of 2021: 25 students – 6 did not pass the first time, all passed the second time. Summer of 2022: 25 students – 6 did not pass the first time, 4 passed the second time.

Dr. Mary Rivard reviewed the following information with the committee. Dr. Rivard announced that until November 30<sup>th</sup> we are taking applications for the January program start. Currently, we only have 20 applications.

  - Enrollment Summer 2022: 59
  - Majors Fall 2022-2023: 80
  - Enrollment Fall 2022: 80

Clarification: Majors is students who have declared as their major, not students who have been enrolled in the program.

### Local Demand

- United Regional is starting an apprenticeship program that will start with LVNs that will begin Spring 2023, hoping to eventually include RN with a 2 year commitment following the completion of program.
- Wilbarger Hospital has program to hire students at certain point in program at an LVN rate of pay.
- Dr. Rivard mentioned United Regional is changing way of patient care and that means that they will be hiring for LVNs.
- North Texas State Hospital is doing more contract work with nurses instead of outright hiring.
- United Regional has over 100 open positions.
- Red River Hospital has over 35 open positions with walk in job fairs ongoing.

# Professional development of faculty and recommendations

Dr. Mary Rivard stated that the test is changing in April 2023. All students will take the Next Gen NCLEX, historically we see a drop in pass rates and it will be interesting because the Board of Nursing will not be changing their requirements. Going back to an Evolving Case Study type of exam where the focus will be for Clinical Judgement Model based on what a nurse should know when they graduate school.

Guest Ashley Miller asked how application process for program was going. Dr. Rivard said August had 50 apply and were able to accept more students, and so numbers are doing very well so far. Vernon also had 10 students enroll for the fall. We will attempt a Seymour option once again this year.

Rachel Gray asked if there were any further discussions or recommendations. Hearing none, Rachel moved on to serving students from special populations.

## **Serving students from special populations:**

Rachel asked the committee to please note the federal definitions of special populations below. Dr. Mary Rivard reviewed the information below for students who qualify.

Vernon College is an open-enrollment college. The Proactive Assistance for Student Services (PASS) department offers many services for documented disabilities such as but not limited to quiet testing, longer testing times, interpreters, and special equipment.

Discussion ensued about being able to use the accommodations used during college with documentation on the NCLEX as well.

Vernon College has a program titled "New Beginnings" for students who qualify to receive transportation, childcare, and/or textbook loans. Perkins funding is also offering assistance to break down barriers such as uniform, supply, equipment costs.

Peer to Peer mentoring, tutoring (online and in-person), resume building, student success series, and counseling are just a few of the other options/services available to students.

  - i. Youth with a parent who
    - i. is a member of the armed forces (as such term is defined in section 101(a)(4) of title 10, United States Code);
    - ii. is on active duty (as such term is defined in section 101(d)(1) of such title).
