# Regular Meeting BOARD OF TRUSTEES

Vernon College December 11, 2019

### Consent Agenda

Mrs. Pennington made the motion, seconded by Mr. Holt to approve the Consent Agenda containing the *Minutes of the November 13, 2019 Regular Board Meeting* and the *President's Monthly Travel Expense Report*. The motion carried unanimously.

<u>Public Comment</u> – No one was present to make comments.

<u>President's Report/Board Discussion Items</u> – No items to discuss.

Annual Continuing Education Enrollment report – Ms. Feldman presented the 2018-2019 Summary for Continuing Education (CE) courses funded by the state (funded non-credit) and the CE personal enrichment classes for community service (non-funded non-credit). She presented comparison charts by major programs, head count, contact hours, total enrollment, and per location at Vernon, Century City Center, and Skills Training Center.

<u>Student Success Data Fact</u> – The Spring 2019 results of the Community College Survey of Student Engagement (CCSSE) was presented by Dr. Donnie Kirk. The survey is administered the 4<sup>th</sup> and 5<sup>th</sup> weeks of the Spring

academic terms. The benchmark results for 1) Active and Collaborative Learning, 2) Student Effort, 3) Academic Challenge, 4) Student Faculty Interaction, and 5) Support for Learners were reviewed. Faculty also participate in the Community College Faculty Survey of Student Engagement (CCFSSE). He also talked about "Success through Inquiry" QEP Impacts, QEP Initiative of Inquiry Based Learning (IBL), and the institutional challenge to develop, establish, and improve student success/learning using IBL practices.
