Regular Meeting BOARD OF TRUSTEES

Vernon College February 12, 2020

The Board of Trustees of Vernon College met on Wednesday, February 12, 2020 at 11:30 p.m. in the *Board Room* of the *Osborne Administration Building*, Vernon, Texas with the following present: Dr. Todd Smith, Chairman, Mr. Norman Brints, Vice-Chairman, and Mrs. Vicki Pennington, Secretary. Action Item H

Mrs. Pennington made the motion, seconded by Mrs. Wilson to approve the *Tax Resale Deeds* as presented by Dr. Johnston. The motion carried unanimously.

<u>Public Comment</u> – No one was present to make comments.

<u>President's Report/Board Discussion Items</u> – Dr. Smith stated he wanted to bring to everyone's mind the loss of Mr. Gene Gooch, past Dean of Administrative Services, and that his wife Susan and family were in our thoughts.

<u>VC Foundation meeting update</u> – Dr. Smith reported on the Vernon College Foundation Quarterly Meeting held January 16, 2020. The Foundation reviewed the College Foundation audit and the 990. The Foundation continued the spend rate for the Foundation scholarships at 5%. The Foundation also approved \$25,000 for Catching the Future Dual Credit Scholarships. Also ratified the appointment of Stephen Brantley as a member of the Vernon College Foundation Investment Committee. Mr. Eric Robb presented an overview of our investments. Dr. Johnston presented his report. Michelle Alexander presented the philanthropic report and Vice President Garry David reviewed the financial reports.

Student Success Data Fact Update – Enrollment Update – Dr. Nordone presented the Preliminary Enrollment report as the Student Success Data Fact for February. It shows the comparison for Spring 2019 versus Spring 2020. It includes Spring (16 week) and Spring 1 (8 week). He stated that generally speaking, when we look at our retention and recruiting efforts, we are not down that much. The report shows where we are up and down at each location. The total for all locations is down -1.31%. The contact hours are up. Dual Credit continues to be strong. There are other variables we look at, a nationwide decrease in high school graduates, the strong economy, the inverse relationship between college enrollment and the strong economy. Dr. Nordone stated he was satisfied with the total change based on the other variables.

<u>Athletic Student GPA report</u> – Dr. Johnston presented the Athletic Student GPA report and the good news they are on an upward trend. The goal is for all sports to be over 3.0 and this is the closest they have come in a number of years.
