### Regular Meeting BOARD OF TRUSTEES

Vernon College March 8, 2023

# President's Report/Board Discussion Items

## Board comments/discussion -

Dr. Johnston gave an enrollment follow-up. Since the last board meeting, he and the President's team have discussed different options to try on enrollment.

## King Farm annual update -

Mrs. Flynn provided an annual update on the King Farm. There isn't much change and the tenants still struggle without rain and are just holding steady. One of the tenants is going to plant grass for his cattle. We will receive 20% of any profit. The other tenant remains on a straight lease. Dr. Johnston stated we are still very fortunate the tenants continue to lease the property.

## Nursing Program Accreditation update -

Dr. Mary Rivard reported that ADN students who acquire an Associate Degree in Nursing from a Texas accredited college and who have passed the State Board Licensure exam are accepted to work for any hospital, or other medical work place within the state of Texas. However, if any of those students move out of state and apply for a job, they have to provide that the school of nursing they received their degree from is listed as a *National* Accredited School of Nursing in order for them to be considered for hire.

Dr. Rivard had been receiving requests from previous students asking if we were a *National* Accredited School of Nursing. She stated the nursing program is in the process of acquiring national accreditation. The program has been approved for all the required Candidacy criteria towards the accreditation. There will be a site visit in February of 2024. Dr. Rivard stated there is no doubt that we will receive the national accreditation.

## Student Success Data Fact -

History of Vernon College Focus on Student Success – Dr. Beauchamp presented the historical listing beginning with Fall 2018 to the current Spring 2023. The document goes back as far as 2009 when it begun. Every department or division continually list initiatives, implementation and processes to improve student success. Spring 2023 Enrollment Snapshot – Dr. Beauchamp's stated the enrollment snapshot for Spring 2023 lists the student demographics of male and gender population, full and part time, ethnicity, dual credit, course enrollments, educational goals, majors, etc. It is a good resource for many usages.
