The Vernon College Athletics Committee met on May 9, 2011 at 1:30 pm in the Board Room of the *Osborne Administration Building* with the following present: John B. - 1. John Hardin III, Dean of Student Services/Athletic Director called the meeting to order.
- 2. After discussion about sports programs to be considered in the future, no new athletic programs for 2011-2012 are recommended due to budget constraints. Additional programs will have to be proposed at a later time. A motion was made by Garry David and seconded by Kevin Lallmann for no new athletic programs to be added in the 2011-2012 school year.
- 3. Sports records and GPA's were discussed. Each sport's prescribed study hall procedures were discussed. Students are assigned study halls depending on how they do on their academic progress reports. Jo Ann Sharp is the athletic advisor that coordinates athletic academic integrity.
- 4. The Athletic Policy and Procedures Manual were reviewed, including: Organizational Structure, Goals, Facilities, Scholarships, Absentee Policy, Student Housing, Publicity, Equipment, Training Services, and Student Right to Know.
