# \* Review program outcomes, assessment methods/results, and workplace competency

Cristi Wisch asked the faculty member, Mary Rivard, to review the following information with the committee.

#### **Program outcomes**

- Create a Safe and Effective Care Environment promotes achievement of client outcomes by providing and directing evidence-based nursing care that enhances the health care delivery setting in order to protect clients and health care personnel.
   Implement Effective Management of Care Techniques – employs and directs evidencebased nursing care that enhances the health care delivery setting to protect clients and health care personnel.
- 2. Promote **Safety and Infection Control** implements measures to protect clients and health care personnel from health and environmental hazards.

- 3. Advocate **Health Promotion and Maintenance** provides and directs evidence-based nursing care that incorporates the knowledge of expected growth and development principles, prevention and/or early detection of health problems, and strategies to achieve optimal health.
- 4. Promote and Support **Psychosocial Integrity** provides and directs nursing care that promotes and supports the emotional, mental and social wellbeing of the client experiencing stressful events, as well as clients with acute or chronic mental illness.
- 5. Promote and Support **Physiological Integrity** promotes physical health and wellness by providing care and comfort, reducing client risk potential, and managing health alterations.

### **Approve assessment methods and results**

Cristi Wisch asked the faculty member, Mary Rivard, to explain in more detail the assessment methods and results.

Mary Rivard reviewed the following information with the committee.

Community—Based Nursing is the capstone course for the ADN Program. The course includes the Hurst NCLEX Review with Elevate course and the HESI Exit Exam. Each student is required to take two HESI Exit Exams and the Vernon College Comprehensive Final (VCCF) in the spring semester. The highest HESI score plus VCCF combined must equal 975 or better. If not passed, the student will be required to repeat the Hurst NCLEX Review and attend remediation in the summer semester.

Andrea Anderle asked if the only new thing was the addition of the Hurst NCLEX review course to the community course.

Mary Rivard stated yes. It will be a requirement plus the Elevate course that will go along with it and the fees for that course has been figured into their fees for the program.

Chrisit Wisch asked the committee for a motion to approve the assessment methods as presented. Robin Lockhart made a motion to approve the assessment methods as presented. Melody Chandler seconded the motion.

### **NCLEX-RN**

## ❖ Program Specific Accreditation Information and Requirements (if applicable)

Mary Rivard reviewed the following information from the Board of Nursing below:

Ongoing approval status is determined biennially by the Board on the basis of information reported or provided in the program's NEPIS and CANEP, NCLEX-RN® examination pass rates, program compliance with this chapter, and other program outcomes. Certificates of Board approval will be mailed to all Board-approved nursing programs biennially in even-numbered years.

- (1) Compliance Audit. Each approved professional nursing education program shall submit a biennial CANEP regarding its compliance with the Board's requirements.
- (2) NCLEX-RN® Pass Rates. The annual NCLEX-RN® examination pass rate for each professional nursing education program is determined by the percentage of first time test-takers who pass the examination during the examination year.
  - (A) A minimum of eighty percent (80%) of first-time NCLEX-RN® candidates is required to achieve a passing score on the NCLEX-RN® examination during the examination year.
  - (B) When the passing score of first-time NCLEX-RN® candidates is less than 80% on the examination during the examination year, the nursing program shall submit a Self-Study Report that evaluates factors that may have contributed to the graduates' performance on the

NCLEX-RN® examination and a description of the corrective measures to be implemented. The report shall comply with Board Education Guideline 3.2.1.a. Writing a Self-Study Report on Evaluation of Factors that Contributed to the Graduates' Performance on the NCLEX-PN® or NCLEX-RN® Examination. Within one year of the submission of the Self-Study Report to the Board, the program shall provide to Board Staff evaluation data on the effectiveness of corrective measures implemented.

Plans are in development for applying to ACEN (Accreditation Commission for Education in Nursing) for national program accreditation. Candidacy/initial accreditation cost is approximately \$13,321.

# Eligibility requirements for the governing organization/institution offering the nursing program seeking initial accreditation with the ACEN

- 1. The governing organization/institution is legally authorized to provide a postsecondary education program in the state or country in which the governing organization/institution and nursing program is physically located.
- 2. The governing organization/institution is legally authorized to grant the credential (degree, diploma, or certificate) for the nursing program seeking accreditation.
- 3. The governing organization/institution is accredited or approved to pursue accreditation by a governing organization/institutional accrediting agency recognized by the ACEN; however, this does not apply to programs outside the U.S. or its territories.
- 4. For governing organizations/institutions included in section C, subsections 1, 2, 3, and 4, that do not hold governing organization/institutional accreditation by a governing organization/institutional accrediting agency recognized by the ACEN:
  - a. The governing organization/institution must be approved to pursue accreditation by a governing organization/institutional accrediting agency recognized by the ACEN; and,

- b. The governing organization/institution must be accredited with a governing organization/institutional accrediting agency recognized by the ACEN before the ACEN Board of Commissioners makes its initial accreditation decision for the nursing program(s) seeking initial accreditation with the ACEN.
- 5. For governing organizations/institutions included in section C, subsection 2, that do not hold or are ineligible to hold governing organization/institutional accreditation by a governing organization/institutional accrediting agency recognized by the ACEN, the governing organization/institution must be approved by a supervisory state education department/public school system/district before the ACEN Board of Commissioners makes its initial accreditation decision for the nursing program(s) seeking initial accreditation with the ACEN.
- 6. The nurse administrator of the nursing program is responsible for immediately informing the ACEN Chief Executive Officer (CEO), in writing, of any change of status with any agency that accredits and/or approves the governing organization/institution. The notification must occur before the ACEN Board of Commissioners makes its initial accreditation decision.

Andrea Anderle asked, what is the benefit of being nationally accredited?

Mary Rivard stated it actually opens up a lot of opportunities for students, there are actually states that require students to be educated in a program that is nationally accredited. We have had a student who went to Alaska and could not take the NCLEX in Alaska so she ended up having to test in Texas and then transfer to Alaska. There are also some agencies that will not hire students from programs that are not nationally accredited; the Veterans Administration is one of those. There are other government agencies that have those same requirements. There are also several universities that will not allow a student to enroll in RN to BSN or MSN if the program is not nationally accredited. The ACEN accreditation standard are a little stricter than some of the state boards of nursing have so it is highly recommended that a program be nationally accredited.

Andrea Anderle we did not fill all of the RN vacancies this year. We are in the market for hiring new graduates. We did hire many traveling nurses this year. It is a little different this year with all the COVID regulations and the nurse to patient ratio being lower on some of the COVID units.

Shana Drury asked Andrea if it was because of limited applicants or was there was another reason for not filling the positions. Andrea stated it was a little of both. They were not able to hire all applicants that applied; some applicants did not fit specific vacancies.

# Evaluation of facilities, equipment, and technology. Recommendation for acquisition of new equipment and technology.

Cristi Wisch asked the faculty member to review the following information. Mary Rivard reviewed the new equipment purchased in the last year. In addition, they purchased many thermometers and tuning forks, reflex hammer and items to make kits for students to check out to do assessments at home during virtual learning.

Andrea Anderle asked if there was any need for virtual learning software or cameras. Mary stated she was glad that question was asked. There have been purchases of web Swift River and V-Clinicals to get graduates out on time in the spring since clinical sites were shut down. Having this software was one of the main things that allowed Vernon College to get graduates out on time. They have started allowing the students to virtual learn during this time as situations are constantly changing. Students are required to come to class to test unless they are in quarantine. If necessary, they can have faculty proctor virtual testing.

  - g. Homeless individuals described in section 725 of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11434a);
  - h. Youth who are in, or have aged out of, the foster care system; and
  - i. Youth with a parent who
    - i. is a member of the armed forces (as such term is defined in section 101(a)(4) of title 10, United States Code);

ii. is on active duty (as such term is defined in section 101(d)(1) of such title).

Vernon College is an open enrollment college. The Proactive Assistance for Student Services (PASS) department offers many services for documented disabilities such as but not limited to quiet testing, longer testing times, interpreters, and special equipment.

Vernon College has a program titled "New Beginnings" for students who qualify to receive transportation, childcare, and/or textbook loans. Perkins funding is also offering assistance to break down barriers such as uniform, supply, equipment costs.

Peer to Peer mentoring, tutoring (online and in person), resume building, student success series, and counseling are just a few of the other options/services available to students.

Cristi Wisch opened the floor for any further discussion. Shana Drury thanked the committee for their service.
