Training Policy/Procedures (215.7 (i) (2); 215.7 (i) (5); 215.7 (i) (6)

- (9) The board may have members who are law enforcement personnel; however, one-third of the members must be public members, as defined in 1701.052 of the Texas Occupations Code, having the same qualification as any commissioner who is required by law to be a member of the general public. The chief administrator, or head of the sponsoring organization, and the designated training coordinator may only serve as ex-officio, non-voting members. Board members are required to successfully complete the commission developed advisory board training course within one year of appointment to an advisory board.
- (10) A board must meet at least once each calendar year. More frequent meetings may be called by the board chair, the training coordinator, or the person who appoints the board.

(11) The Training Coordinator (TC) has the authority to develop or modify the training based upon specific criteria such as weather, enrollment level, needs, mandates, etc. The TC can establish and enforce policies on admission and prerequisites, class size, attendance/retention standards, and determining order of admissions preference among students and appointees in consult with the administration, etc. The TC can make recommendations for the change to policy, and if none, seek a motion/second and vote to proceed with no changes; thus the board has acted on the required topic.
