MINUTES

Key Discussion Points	Action ,Discussion, or Information
Welcome & Introductions	Meeting was called to order. Members introduced themselves and the company they worked for as well as expertise.
Purpose of Advisory Committee	Dr. Gary Don Harkey thanked the members for serving on the committee and explained the role of the advisory committee members for the workforce programs.
Election of Chair and Recorder	Lee Ritchie was elected chairperson. Kitty Howard was elected recorder.
Approval of Minutes from the Last Meeting	Minutes from last meeting were approved as presented.
Old Business: (if any, otherwise type None)	EPA tests were given for the first time as a mandatory part of the course HART 1407 and only two passed all sections the first time around. Scott gave a free retest and two more passed. Members asked why such a low number on the first try. Scott told members he believed the students just do not study. Members voted and agreed that Scott should charge students a \$100.00 retest fee to take the test again since that is what happens in the industry. Since there is no retest fee for the college, members suggested that the \$100.00 retest fee be donated to the "Stanley and Betty Ray HVACR Scholarship" fund. This was also voted on and passed.

Continuing Business: (List if any, otherwise type None)	A \$500.00 Stanley and Betty Ray Scholarship was awarded to Jose Chavez, who is a HVAC student this semester.
New Business:	
Review program outcomes, assessment methods, and results	The members were given a handout of the program's goals & outcomes. Members read over them and felt that they are relevant and necessary for today's workforce. They changed the wording on # 4 to –understand load principles- from calculate loads, and then voted and approved as amended.
Review program curriculum/courses/degree pans	Members looked over the certificate and degree plan and agreed to add ITSC 1301 Introduction to Computers as an elective.
Review SCANS and Gen Ed outcomes matrices	Members were handed a printout of the Scans and General Education Outcomes Matrices. After review, members changed the wording on # 4on the Outcome Matrix to reflect the change to the program outcomes and then voted and approved as amended.
Review verification course/exam of workplace competencies	Members discussed the capstone course HART 2436 Air Conditioning Troubleshooting, and the rubric used to grade it. Members were in agreement that this course covers all the workplace competencies and the rubric used to grade it is more than sufficient.

Professional development of faculty and recommendations (if applicable)	Scott attended various faculty development sessions put on by Vernon College. He attended training covering Rheem's new high end equipment. He has been viewing webinars from RSES in classes when possible which include Defrost in Commercial Applications, Charging Heat Pumps, and Customer Relations. Scott asked if anyone knew of a good training on mini-splits.

Promotion and publicity (recruiting) about the program to the community and to business and industry (gender equity)	Sophomore Roundup is November 20 th and GenTX (a 1-day statewide college application drive for the State of Texas) is scheduled for May.
