As we approach the upcoming 2012/2013 academic year, I would like to take some time to update you on the program. Our student enrollment has been declining over the past couple of years, but we are very constant with about 10 to 12 graduates a year. This number represents twice the needed amount to satisfy state requirements. Also, the program was able to receive an additional compact logic trainer through received Spring Perkin's adjustment funding. These three trainers will be added to the curriculum in ELPT 2449, Industrial Automation in Spring 2012. Other Fall 2012 discussion topics will be possible changes to the basic certificate program, the addition of an advance certificate degree and an additional Associate degree option for the machining students.

For the upcoming fall meeting, our main focus will be getting feedback on the proposed additional changed format of the Associate degree program. This addition to the Industrial Automation program will offer a second option for graduates in advanced manufacturing/Machining. This was done to give the machining students an option to continue their degree plans into an associate's level training in Industrial Automation. We will also brainstorm possible initiatives to increase enrollment along with reviewing program statistical data.
