AAD Program	Upon receiving approval from Vernon College Academic Council Jeff notified ARC/STSA in August 2012 of the Inactive Status for the AAD Program. The AAD Program is now Officially Inactive Status.

Implementation	November, to the CAAHEP for their final approval.	
New Business:		
Program statistics: Graduates, majors, enrollment	Jeff provided the committee data on the current class and historical data on enrollment and retention in the traditional program. Accreditation standard is 70% retention. The 2011-2012 traditional class 15 of 15 completed with 100% retention rate, AAD class 4 of 5 completed for 80% retention rate. Pre-Requisites definitely helped with retention. There are currently 13 students in the program, 11 females and 2 males. No recommendations were made for changing retention efforts.	
CST exam results	Jeff provided the committee with data on the CST exam results from the recent class. Accreditation standard is 70% pass rate. The 2012 traditional class pass rate of 87% was discussed with Jeff providing feedback on how the decision to have extensive study sessions this summer really paid off. The members were pleased.	
Review goals and objectives	The committee reviewed goals and objectives with no changes/updates suggested.	
Program revisions and	Jeff discussed with members benefits the new curriculum revisions	
curriculum/course review	provided the students because it better aligns with CST exam. There was a course code change on Medical Terminology. The code was SRGT 1201 and is currently coded HRPS 1206.  He also provided the members with the schedule changes for the fall 2013 semester and it will result in a \$50.00 increase in the special fee added to courses SRGT 1405, 1409, 1441, and 1442. The fee increased for the Essential of Medical Terminology from \$16 to \$24.

Evaluation of facilities, equipment, and technology	Jeff provided information he ordered supplies to finish off the fall and spring semester totaling \$3900.00. VC lost Kell West as a clinical site. Wilbarger General Hosp is a new site providing 2 slots for 2012-2013

There was no Perkins Grant funding allotted to Surgical Technology this academic year.  Dr. Harkey provided information on how grant monies was largely being spent on Allied Health Wing itself, HIT computer lab in Vernon and conferences.
Recruitment and retention of the underrepresented gender in genderbiased programs	Jeff reported he continues to recruit male and minority students and the college continues to provide assistance in recruiting male students. The Guys Night Out held at the Century City Campus on October 9 <sup>th</sup> , was a great success. Both Terry Porter and Delayne Crowe said they could participate in underrepresented gender functions when possible. No recommendations were made for recruitment and retention of the underrepresented gender population.
Other:	Jeff provided members with an update about the program student association activities. Students will be participating in an emergency evacuation drill at URHCS on Nov. 5 <sup>th</sup> from 9am-11am. Students are fundraising (selling cokes, salsa and poinsettias) to attend the March 2013 AST State Business Meeting in Ft. Worth, TX. If enough money is raised 7 or 8 of the students want to attend the AST National Conference in New Orleans. He also reported the STSA volunteered with other Vernon College students and the Administrative Staff, in a Vernon College Day of Service. The group worked with Habitat for Humanity on Saturday, October 20, 2012.
