## 2011 – 2012 Vernon College Scholarship Committee

The Vernon College Scholarship Committee held its spring meeting on Wednesday, April 20, 2011 in the Board Room on the Vernon Campus.

## Call to Order

Ms. Alexander called the meeting to order at 2:05 p.m.

## 1. Approval of Minutes – April 22, 2010

Action: Mrs. Munson moved approval; seconded by Mrs. Elliott. The motion carried unanimously.

### 2. Discussion of Funding Options

Ms. Alexander reported that 374 completed applications were submitted through the STARS on-line application process. Currently \$114,618 is available for awarding 2011-2012 Scholarships. On April 22, the Vernon College Foundation will hold its quarterly meeting and an item on the agenda is the amount of funds the Foundation will take from its general fund to use for Foundation scholarship awards. If the Directors approve the proposal, this will raise the amount available for all scholarship awards to \$133,938.

The committee discussed several funding options. It was agreed that 60% of the available funding should be used to recruit new students. All residual funds should be used for returning students.

### **Consideration of Action Items**

### a) New Students

Scholarships for 2011-2012 will be awarded, based upon class rank, to students in the top 50% of their graduating class, based upon the table outlined below for a total of \$62,500.

Action: Ms. Alexander called for the vote. The motion carried unanimously.

### b) Returning Students

Action: Dr. Gary Don Harkey proposed that returning students who have completed at least 33% of their program should be eligible for scholarship consideration. Ms. Munson seconded. The motion carried unanimously. Further action regarding award amounts was tabled until the spring 2011 semester grades are turned in. Once that is done, and grade point averages and program completion percentages are updated, Ms. Alexander will develop the award methodology and submit to the Committee via email for a vote.

## c) Full-time Employee Dependents

Action: Dr. Gary Don Harkey moved for approval the dependents of full-time Vernon College employees be awarded \$500 in addition to any other scholarship award; seconded by Ms. Shana Munson. The motion carried unanimously.

## d) Institutional Scholarships

Institutional Scholarship funding will remain level with 2010-2011 according to the table outlined below.

### e) Out of State Students \$1,000 competitive scholarships

Action: Mr. Joe Hite moved approval that all out of state students awarded a competitive scholarship with a minimum value of \$1,000 will be eligible for in-state tuition; seconded by Mrs. Melissa Elliott. The motion carried unanimously.

#### f) Scholarship sub-committee

Ms. Brandi Ballard and Dr. Gary Don Harkey volunteered to serve on the Scholarship subcommittee along with Ms. Michelle A. Alexander. **Action:** Mr. Garry David moved for approval; seconded by Mrs. Melissa Elliott. The motion carried unanimously.

### 3. Other Business

Mr. Jeff Feix asked for approval in creating a sub-committee to award the Cindy Asher and Bonnie Barnard Scholarships which go to students in the Surgical Technology program. All were in favor.

## 4. Adjournment

Mrs. Melissa Elliott moved adjournment at 2:56 p.m.; seconded by Jeanne Ballard. The motion carried unanimously.
