Council members reviewed the Substantive Change Policy and recommended no revisions.

Council members reviewed the developmental course revisions proposed by the 60x30, SB 24, TX Guided Pathways Task Force. The bill mandates that students who do not successfully complete their first attempt in Developmental courses be given an intervention in addition to retaking the course. The proposed 2-hour labs for MATH 0400 and MATH 0313 will fulfill the requirements for HB 2223. This NCBO (Non Course-Based Option) may be required by Math faculty for those students who have either dropped or were unsuccessful in MATH 0400 Foundations of Math or MATH 0313 Developing Algebra Skills I. The Skills Lab courses will be submitted for approval at the next Academic Council Meeting. There is no additional charge for the intervention.

Program Information- “A minimum grade point average of 2.0 for prerequisite courses is required for admission.” “All students will be required to take the nursing pre-admission entrance examination (HESI A2).” “Anatomy and Physiology II, BIOL 2402 must be completed by the end of the first semester in the LVN Program. Lifespan Growth and Development, PSYC 2314 must be completed by the end of the second semester in the LVN Program. These courses may be completed prior to LVN Program enrollment. A grade of “C” or better is required for program progression. Any student not completing Anatomy and Physiology II by the end of the first program semester or Lifespan Growth and Development by the end of the second program semester, with a grade of “C” or better, will be dismissed from the LVN Program.” “Submit evidence of a physical examination that has been performed within six months of acceptance (first program class day) to the nursing program.”

April 2020 (electronic meeting):

Substantive Change notification to the Southern Association of Colleges and Schools for the Barber Program. This change was the result of House Bill 2947 presented by the Texas Department of Licensing and Regulation (TDLR) during the Texas 2019

legislative session. The law mandates a decrease in the required number of clock hours for a Cosmetology student to be eligible to take the TDLR Licensing/Credentialing exam effective September 1, 2020. With this mandate on the Cosmetology licensure, it was only prudent for TDLR to mandate a decrease in hours for the Barber licensure as well. As a result, programs teaching 1500 clock hours must reduce to a minimum of 1000 clock hours.

Program Evaluation Recommendations-

The Program Evaluation Committee recommended keeping the following three evaluated programs on their present five-year evaluation term. All evaluated programs reported comprehensive findings, which indicated strong programs. The committee chair will present within the following month a more detailed summary to the Vice President of Instructional Services and Dean of Instructional Services.
