Amanda Raines seconded the motion. Mary explained that upon approval, the revisions will be published in the 2019-2020 General Catalog as a tool for advising new students entering the program in Fall 2020. She explained that the content of the courses deleted from the program will be added to the remaining courses. BIOL 2401 A & P I will be a prerequisite for admission into the program and BIOL 2402 A & P II and PSYC 2314 Lifespan Growth and Development will be required as companions to specific vocational nursing course work. The recommended changes are in response to weaknesses in prior

students' success rates for the NCLEX-PN Examination. Forty-seven total semester hours are included in this proposed certificate of completion. Melissa Moore asked about articulation agreements with the area high schools. Mary Rivard replied that she is working on updating that information. Committee members voted unanimously in approval.

G. Associate Degree Nursing 2019-2020

At the recommendation of the Associate Degree Nursing Advisory Committee, Mary Rivard motioned to increase the Nursing Central Fee from \$215.00 to \$225.00 for the following courses:
