I. OLD BUSINESS

A. Review of Minutes – January 31, 2019
Greg Fowler motioned to approve the minutes as presented; Shana Drury seconded the motion and the committee voted unanimously in approval.

II. NEW BUSINESS

A. Cosmetology

Shana explained that as result of the State mandated reduction of contact hours from 1500 to 1000, the following revisions were approved by the program's advisory committee. Greg Fowler seconded the motion and committee members voted unanimously in approval. C. College Physics Paula Whitman Paula Whitman made a motion to delete PHYS 1401 College Physics I and PHYS 1402 College Physics II from the Vernon College course inventory. She explained that VC students do not typically need these courses. Shana Drury seconded the motion and it passed unanimously. Shana commented that these course deletions will be submitted to the Coordinating Board as core curriculum changes. D. Occupational Skills Awards Shana Drury Shana presented the Occupational Skills Awards for 2020-2021 for council members to review and she motioned to accept the awards as presented. Greg Fowler seconded the motion and it was unanimously approved. E. Associate of Science and Associate of Arts Degrees Joe Johnston Joe directed council members' attention to the revised degree plans for Associate of Science and Associate of Arts. Clara Garza suggested that electives for the Associate in Science degree be divided equally (6 each semester) between the Sophomore Year Fall and Spring semesters. Joe explained that the degree plan revisions lead students to reference the Vernon College Core Curriculum Requirements table and counselors will assist students in making the choices based on their future educational goals. Shana Drury seconded the revised motion and committee members voted unanimously in approval. F. CTE Verification of Workplace Competencies Shana Drury Shana asked council members to review the CTE Verification of Workplace Competencies and she made a motion to approve the listings for 2020-2021. Greg Fowler seconded the motion and it was unanimously approved. G. Substantive Change Policy Shana Drurv Shana asked council members to review the Substantive Change Policy. No changes were recommended. Marian Grona seconded the motion and it was approved by unanimous vote. III. OTHER A. Advanced Technical Credit Shana Drury

- Shana reviewed the courses listed for Advanced Technical Credit for 2020-2021. She explained that this will be the last year for the credits to be offered but the college will continue to process credit requests as students graduate from high school.
- B. Core Objectives Update Dr. Brad Beauchamp Brad Beauchamp reported that students are assessing social responsibility during the Spring

2020 semester. Communication will be the assessment topic for Summer 2020.

- C. Developmental Math Paula Whitman Paula reviewed developmental course revisions proposed by the 60x30, SB 24, TX Guided Pathways Task Force. The bill mandates that students who do not successfully complete their first attempt in Developmental courses be given an intervention in addition to retaking the course. The proposed 2-hour labs for MATH 0400 and MATH 0313 will fulfill the requirements for HB 2223. This NCBO (Non Course-Based Option) may be required by Math faculty for those students who have either dropped or were unsuccessful in MATH 0400 Foundations of Math or MATH 0313 Developing Algebra Skills I. The Skills Lab courses will be submitted for approval at the next Academic Council Meeting. There is no additional charge for the intervention.
