ACADEMIC COUNCIL MEETING MINUTES Friday, February 28, 2015 Interactive Video Classrooms Vernon Campus and Century City Campus

I. Old Business

A. Approval of Minutes

Greg Fowler motioned to accept the January 30, 2015 minutes, seconded by Karen Gragg. The motion passed unanimously.

II. New Business

A. Developmental Math

Dr. Karen Gragg motioned to revise the developmental math course offerings as follows. Revise: ACMS 0101 Academic Mathematic Skills by removing the phrase, "Includes modules to reflect just-in-time review for Contemporary Math." Also remove the exact definition of "bubble" students.

Add: ACMT 0100 Academic Math Transitions as a Non Course Based Option (NCBO) as a corequisite for students scoring below ABE level 5 on the TSIA.

Add: MATH 0300 Pre-Algebra for students scoring TSI 335 or below and as a co-requisite of ACMT 0100 for students scoring below ABE level 5 on the TSIA.

Delete: MTRN 0040 Math Transitions

Joe Johnston seconded the motion and it received unanimous approval.

B. Computer and Information Sciences

In Mark Holcomb's absence, Shana Drury made a motion to revise the CIS certificate and degree plans as recommended by the program advisory committee. Revisions include deleting Cisco related courses, ITCC 1301, ITCC 1304, ITCC 2308 and ITCC 2310 and adding ITNW 2312, ITNW 2321 and ITNW 2353. These revisions are also reflected in the Marketable Skills Achievement Awards and the Verification of Workplace Competencies for the program. Cathy Bolton seconded the motion and it passed unanimously.

- **C.** KINE 2356 Care and Prevention of Athletic Injuries Dr. Gragg made a motion to revise the course description by removing the prerequisite from the course. Shana Drury seconded the motion and it passed unanimously.
- D. Developmental Reading and Writing

Joe Johnston made a motion to add DEVR 0100 Developmental Reading (NCBO) as a corequisite with ENGL 0305 for students with TSIA reading ABE score lower than 4. He also included in the motion the addition of DEVW 0100 Developmental Writing (NCBO) as a corequisite with ENGL 0305 for students scoring TSIA writing ABE score of 4 and lower. The third revision to the developmental reading and writing course offerings is the addition of ENGL 0306 Integrated Reading and Writing II for students that successfully complete ENGL 0305 (grade C or better) or TSIA Reading score above 340 and Writing score above 350 (no ABE). Successful completion of this course fulfills TSI requirements for reading and/or writing. Cathy Bolton seconded the motion and it received unanimous approval.

E. CLEP Test Score Requirements

Kristin Harris explained that CLEP Board regulations have been revised to allow the Century City Testing Center to administer CLEP tests. The test score requirements already in place for the Vernon Campus will remain with the following revisions:

- The addition of the CLEP test for American Literature (ENGL 2327 and ENGL 2328) with required college credit score of 50
- The addition of the CLEP test for Human Growth and Development (PSYC 2314) with required college credit score of 50
- The addition of the CLEP test for Financial Accounting (ACCT 2401) with required college credit score of 50
- The revision of the college credit score to 63 for Spanish Level 2 (SPAN 2311 and SPAN 2312)

Kristin made a motion to approve the CLEP Test score requirements as listed and to begin administering the tests at the Century City location. Greg Fowler seconded the motion and committee members voted unanimously in approval.

III. Other

A. 2014-2015 Dual Credit Course Offerings Review

Dr. Harkey reported that Vernon College is currently delivering dual credit courses to five high schools where students could possibly earn 25% - 49% of the credit hours required for an Associate Degree on-site at the high school. These include Crowell, Iowa Park. Rider, Vernon and Wichita Falls. As required, SACSCOC will be notified.
