Brad reported that the End of Semester Course Review (ESCR) reports from faculty measured above the benchmark. He stated that the Fall 2019 Core Objective was Critical Thinking and all items scored above the benchmark. In Spring 2020, Social Responsibility was evaluated and one item fell slightly below the benchmark. He commented that he will monitor the item to make sure there are no issues that need to be addressed. The Summer 2020 Core Objective evaluation addressed Communication and the data for that report is being processed. The Fall 2020 topic is Teamwork and Spring 2021 will cover Empirical and Quantitative Reasoning.
