Thank you for the update on the calendar committee. I still believe that we are putting a great deal of effort in to squeezing and possibly compromising important institutional functions for the opportunity for a 10 working day Christmas break versus a 9 working day Christmas break. Vernon College employees already have an extremely fortunate working schedule and environment. To my knowledge, in addition to the Christmas break, all employees enjoy 80 hours a year of vacation, 40 hours during Spring Break, and numerous other state and federal holidays. In addition, over time the Vernon College work week has been reduced from the normal 40 hour week to 36 hours per week during the fall and spring semester and to a 34 hour work week during the summer. Each member of our administrative team and all employees really need to be more aware of the continuing attitude of taxpayers across the state and the country in regard to the "perceived" good deal that public employees have.

With that clearly stated I am personally more comfortable in closing at the end of the workday on Tuesday, December 18, 2012 and returning to work at 8:00 am on Wednesday, January 2, 2013. I can think of no valid reason that I am willing to publicly state as to why the college would be closed on January 2. We have many students and community members who will be anxiously awaiting our return to answer questions, etc. for the spring semester. And, as I will continue to state, the students and the community members are the reason we all have jobs.
