- Approval of March 27, 2015 minutes (Exhibit A, Action Item) – document was emailed to CE Committee members and approved by majority vote.
- Student Learning Measures Update: Dr. Gary Don Harkey – Assessment groups met in May to review student artifacts and assessed student achievement of the core objective Personal Responsibility. Summer includes a review of the Teamwork core objective.
- Director of Institutional Effectiveness Update:
 - SACSCOC Fifth-Year Interim Referral Report – Notification was mailed on July 1, 2015 from SACSCOC. Vernon College must submit a monitoring report on CS 3.13.3 (Complaint Procedures Against SACSCOC or its Accredited Institutions) and CS 3.14.1 (Publication of accreditation status) by September 7, 2015. Subject matter experts are working hard to address the concerns listed by SACSCOC. The SACSCOC Vice President assigned to Vernon College has agreed to review the information prior to submission. The report will be studied just prior to the December 2015 Annual Meeting by the SACSCOC Compliance and Report Committee. Contact Betsy with any questions.
 - Student Success by the Numbers Committee – April 9, 2015 served as a combined April/May meeting for the SSBTN Committee. The meeting agenda included a review of updated KPIAs as well as a review and approval of Benchmarks. All updates were emailed to the Data Group which includes College Effectiveness Committee members and posted on the Vernon College website.
- Mathways Project Update : Dr. Karen Gragg - The **New Mathways Project** (NMP) is a systemic approach to improving student success and completion through implementation of processes, strategies, and structures based on four fundamental principles:
 1. multiple mathematics pathways with relevant and challenging content aligned to specific fields of study
 2. curriculum design and pedagogy based on proven practice
 3. intentional use of strategies to help students develop skills as learners
 4. acceleration that allows students to complete a college-level math course more quickly than in the traditional developmental math sequence

Math faculty at Vernon College, during their redesigns of developmental math for NADE certification and the S3 grant, implemented two pathways; one to College Algebra, and the other to Contemporary Math/Statistics. Faculty recommend that students successfully complete

Contemporary Math or College Algebra before taking Statistics to better prepare for the Statistics course.

In Summer 2014, TSI rules were changed to support the implementation of multiple mathematics pathways. Colleges may now designate students as TSI complete for all entry-level mathematics courses (College Algebra, Contemporary Math, Statistics) or TSI complete for non-algebraically-intensive mathematics courses (Contemporary Math, Statistics).

The **Mathematics Pathways Transfer Inventory**, developed by the NMP at the UT Dana Center, includes the latest mathematics core curriculum and major requirements for all public 4-year institutions in the state to aide in advising students to the best-suited pathway.
