**Use of data:** This Texas Higher Education Coordinating Board Report allows institutions to provide data on the placement of graduates that have not been located during matching with higher education enrollment and employment records. The CBM data is combined with other THECB data on local graduates to determine the graduate placement rate for Vernon College. Follow up information is documented in the THECB Accountability System and Perkins Data Resources (used to determine Perkins funding).

This data is also a Vernon College Key Performance Indicator of Accountability with a Benchmark of 85% over a three year period. It is reviewed by the Student Success by the Numbers Committee and the Board of Trustees.

An additional use of this data is evidenced through Program/Discipline reviews and Advisory Committee discussions.
