It is important to include that Vernon College collects success rate results from all licensure and certification tests while gathering the requested information from the THECB for the Vernon College KPIA. Results of all Vernon College related licensure and certification exams:

- AY 2014-2015 for all students tested and passed during that academic year was 86% (825 students tested, unduplicated with 707 passing)
- As compared to AY 2013-2014 at 80% (768 tested with 616 passing).

Use of data: Licensure/Certification Rates is a Vernon College Key Performance Indicator of Accountability (KPIA) with a Benchmark of 90% success rate to mirror the Perkins Program Measures Statewide Target. In addition to success rates used by Perkins and publicized by the THECB, the rates are reviewed by the Student Success by the Numbers Committee, Board of Trustees, during Vernon College Program Evaluations, accreditation/credentialing reviews and by advisory committees.
