Title: Continuing Education Reports

Date of completion: October 2017

Highlights of data:

For 2016-2017, Continuing Education served 4293 unduplicated students. Total enrollment for 16-17 was 7,090 which includes all funded, community service, business and industry and kids college enrollments. Continuing Education offered a total of 1022 funded and non-funded courses for 2016-2017. The top three programs producing the most contact hours are as follows:

1. Correctional officer/jailer with 72,206 hours
2. CNA high schools with 48,661 hour
3. Police Academy with 29,632 hours

Contact Hours per location are as follows in the 2016-2017 Continuing Education reports:

Century City Center – 53,372 hours

Remote Sites – 52,544 hours

Vernon Campus – 9,523 hours

Skills Training Center – 124,302 hours

This is a total of 239,741 contact hours for 2016-2017 resulting in an 8.8% decrease from 2015-2016 (263,065).

Continuing Education reports show 399 contract courses for Business and Industry and 496 courses for Kids College offered in 2016-2017.

Ethnicity ratios are as follows for 2015-2016:

White = 72.49%

Black = 8.74%

Hispanic = 14.98%

Asian = 1.33%

Indian = 1.07%

Other = 1.40%

Texas Higher Education Coordinating Board standards state that Continuing Education should have at least a 90% satisfactory or better rating on the following: quality of course, outcomes met, and needs addressed. For 2016-2017 Continuing Education ratings are as follows:

Quality = 98.98%

Outcomes = 98.65%

Needs = 98.24%

Use of data:

This data is analyzed by the Directors and Coordinators of Continuing Education every year to see what changes are necessary as well as evaluate trends in the market.
