

August 2013 Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance – Dr. Dusty R. Johnston

- The Vernon College Board of Trustees conducted a board retreat on the morning of July 17. The two primary focuses of the retreat were a board self-assessment activity and an update on processes and practices related to the student success agenda. Dr. Bud Joyner facilitated the board self-assessment process and later reported several positive aspects of the board's communication, work ethic, and understanding of the board's role in governing the college. - A significant discussion item at the July 17 regular board meeting was the 2013-2014 budget. All departments were involved in formulating the first draft of the budget. The budget has undergone modest revisions based on expected revenues, additional expenses, and tax appraisal information. The 2013-2014 budget includes a total of 3% salary increases and an expectation to lower the current tax rate due to increases in total tax base appraisal. The proposed budget will be approved at the August 21 board meeting. Two tax rate hearings will be conducted in early September and the tax rate will be set at the September 18 board meeting.
- Board information at the July 17 meeting also included a detailed update of Private and Public Grants to the College since March 2009. Grants were categorized into those that benefitted operations, training grants, and scholarship grants. Vernon College has benefitted from these grants for a total of \$5,325,500 since March of 2009.
- One of several recommendations of the Security and Safety Task Force was the implementation of a mass notification system. Implementation of a mass notification system for students and employees in underway and should be functional early in the fall semester. The system is called RUNSYNC and was developed by Run Business Solutions. More detailed information will be provided to students and employees once the system is fully implemented.
- The renovation of the entry way canopies at Century City Center is nearing completion. The entryways make a very nice addition to the campus. The renovation is scheduled to be complete by the time classes start for the fall semester.

Instruction – Dr. Gary Don Harkey

- Classes for the Summer 11 and Summer II terms are nearing completion with Final Exams scheduled for August 12-13.

The most recent updates to the <u>Texas Higher Education Data website</u> are the Automated Student and Adult Learner Follow-Up System Report (ASALFS) and the 2013 Closing the Gaps Progress Report.

THE ASALFS is for the Vernon College 2011-2012 Exit Cohort. It tracks graduates, completers and non-returners. The report includes information such as the top 10: industries for employment, higher education institutions for enrollment, areas for enrollment, and outcomes by major.

The 2013 Closing the Gaps Progress Report evaluates how far higher education in Texas has come in the areas of participation, success, excellence and researching since the Closing the Gaps by 2015 plan began in 2000.
