

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

### College Governance – Dr. Dusty R. Johnston

- The Board of Trustees accepted the 2010-2011 Vernon College audit prepared by Edgin, Parkman, Fleming & Fleming, PC at the December board meeting. The audits of Vernon College and the Vernon College Foundation financial operations were "acceptable and clean" audits as presented.
- The renovation at Century City Center continues at a very good pace. Most of the demolition is completed and most of the walls for the new renovation are in place. Renovation is on pace to be completed by July 15, 2012. Additional space to be renovated in the currently occupied space should be renovated by October 2012. A great amount of work was completed in the west parking lot over the Christmas break to add green spaces and waterlines.
- Professional development activities are planned for all employees on Monday, January 9, 2012. The majority of the meeting will be a "DATA DAY" to share significant college data with all employees. In addition, a round table discussion will be held by Dr. Johnston to allow an opportunity for input from employees to assist in improving college wide processes and practices. An additional faculty development day is planned for Friday, January 13, 2012.
- All employees are encouraged to participate in the 2012-2013 planning process that is now underway. The 2012-2013 annual action plan will drive budget decisions for the next year. All employees and departments are encouraged to review the 2011-2012 annual action plan to ensure that they are making steps to accomplish the actions in the plan.
- The informal coffee sessions conducted prior to Christmas to provide an opportunity for input were very successful. Ideas that will be follow-up on include:
  - Review of testing center and pass center operations for instructional testing
  - Future auditorium improvements on the Vernon campus
  - Review of additional resources to help with increase in VA students attending Vernon College
  - Explore additional usage of notepads in classrooms and by faculty
  - Explore a paper recycling effort for the College
  - Explore additional on-line tutoring for development math, etc.
  - Additional information in regard to RUNBIZ employees and protocol
