

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance – Dr. Dusty R. Johnston

- At the October board meeting, the Trustees approved a proposal for an outside company to provide support for the Vernon College information technology infrastructure and operations. The contract with Run Business Solutions (RBS), based in Amarillo, Texas, officially began on November 1, 2011. RBS has been working with the college for several months on the implementation of a significant upgrade in infrastructure technology as well as finalization of the update college website. RBS is, for all practical purposes, the Vernon College IT department. All employees have been provided information in regard to new IT protocol to receive service and assistance. The first few weeks will be full of change and learning as we move forward to fully benefit from the relationship.
- The demolition stage of the Century City Center renovation project is in full operation. The project has gotten off to a very fast start. There were some unanticipated moves for several classes and instructors that have gone very smoothly. Administrators, faculty, and students have been innovative, creative, cooperative, and patient to accomplish so much in such a short time period.
- A pilot "DATA DAY" was conducted on Friday, October 28 with a cross section of administration, division chairs, faculty, and administrative and classified office personnel. The primary purpose was a thorough presentation of CCSSE data, KPIA data, and "Student Success by the Numbers" information. The goal is to fully integrate the use of data in planning and decision making throughout all departments and all classification of employees. The "DATA DAY" will be a significant part of the agenda for spring professional development for all employees on Monday, January 9, 2012. The goal is for this presentation of data to be an annual function for the spring semester professional development agenda.
- The Advancement department has been working hard to produce a "President's Annual Report" for Vernon College. The first report will be very heavy with data and planning information and light on "the extras". Future reports will contain important information, but also have more of a marketing flavor. - [°] Wheat is planted. Amazing what a little rain can do.


College Effectiveness – Betsy Harkey
