

October 2012 Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance - Dr. Dusty R. Johnston

- The Vernon College Board of Trustees approved the 2013 tax rate at the maximum operating rate of .222854/\$100 of appraised value. This is a slight decrease from the previous year operating rate, but due to increased property values the rate will increase tax revenues for college operating expenses by approximately \$125,000 per year. This increase was reflected in the approved 2012-2013 operating budget.
- The Course Scheduling Advisor (CSA) system that has been implemented continues to be a great enhancement to meeting the needs of students and to streamlining the registration process. From April through August, CSAs assisted 1283 students in Vernon College CSA centers in Vernon and in Wichita Falls for summer and fall registrations.
- The summary of 2011-2012 annual plans are being finalized. We should all be working from our current 2012-2013 annual plans that were developed and approved this past spring. Planning will soon begin to develop the 2013-2014 annual plans. All departments are encouraged to review SACS criterion to ensure they are addressed in the 2013-2014 annual plans and future planning documents.
- At the October meeting, the Vernon College Board of Trustees will review and approve the College's Philosophy, Vision, Values, and Mission statements as well as the 2013-2017 Long Term Objectives. These are important components of the planning process that are continually reviewed by the College Effectiveness committee and revised, if needed, annually.
- Several Vernon College Board of Trustee members will attend the Texas Higher Education Coordinating Board Leadership Conference in Austin October 4-5. Specific to community college board members are sessions to meet recently mandated training, as specified in HB 1206 from the regular session of the 82nd Texas legislature, which will include best practices in campus financial management, financial ration analysis, and case studies using financial indicators.
- The fall headcount enrollment stands at 3124 as compared to last year's enrollment of 3252 which represents a 3.9% decrease. Early indications are that the statewide enrollment is down about 4%. Contact hour generation is down by 2.8% which is also near the state wide decrease as well. Observations around the state regarding the decrease include uptick in the economy and availability of jobs, time limits of several dislocated worker training fund opportunities, and meningitis vaccination issues of incoming freshmen.

<u>Instruction - Dr. Gary Don Harkey</u>

- Development of the Spring 2013 Class schedule is underway.
- The 2012 Vernon College Access Program (VCAP) meeting was well attended with 36 high school administrators and counselors representing 24 of our service area high schools in attendance. The meetings were held at the newly renovated Century City Center and included tours of the new facilities as well as basic information regarding Academic & CTE programs, dual credit, transfer, and scholarship opportunities. Kudos to Early College Start Coordinator **Jessica Sutherland** for her role in coordinating this successful event.
- Cosmetology Director **Darlene Kajs** recently attended the first Knox County Career Event where she provided information about Vernon College and the Cosmetology program. The event focused on potential careers and students from all schools in Knox County attended.
- Melody Bell, Donnie Kirk, Joe Johnston, Karen Gragg, and Gary Don Harkey recently attended the North Texas Community College Consortium (NTCCC) Fall Leadership Convocation on the Collin College Spring Creek Campus. Biology instructor Melody Bell was recognized as a 2012 graduate of the Consortium Leadership and Renewal Academy (CLARA) while Speech Instructor Donnie Kirk will participate in CLARA during the 2012-2013 year.
- The Surgical Technology Student Association (STSA) celebrated *National Surgical Technologists Week*, September 16 to 22 by filling 100 "goodie bags" that were delivered to United Regional for the Surgery Department, Sterile Processing Department, and Labor & Delivery. Graduates of the program

are employed in each of these areas and current students perform clinical rotations in each area also. This is the 11th year the STSA has provided clinical sites with the goodie bags that are filled with candy during Surg Tech Week.

- Cosmetology Director **Darlene Kajs** has been selected to serve on the Examination Committee of the Texas Department of Licensing and Regulations (TDLR). The committee meets twice each year in Austin and reviews the licensing exams administered by the agency. Congratulations Darlene!
- Joe Johnston, Greg Fowler, Karen Gragg, & Jessica Sutherland recently participated in the first of several AVATAR (Academic Vertical Alignment Training and Renewal) work sessions to be held at the Region IX Educational Service Center in Wichita Falls. AVATAR is a statewide network, comprised of regional efforts, focused on vertical alignment to support students' college and career readiness and success. The project is funded by the THECB.

The Strategic Plan components will be presented to the Board of Trustees at their October meeting for final review and adoption.
- Betsy Harkey is in the process of updating the Key Performance Indicators of Accountability. The updates will be presented at the College Effectiveness Committee meeting on October 30.
- Student Success by the Numbers has three homework assignments that must be completed by January: 1. A structured review of Vernon College's most recent CCSSE results 2. Work with student cohort data 3. Culture of evidence inventory. Meetings will be scheduled to accomplish these tasks as more information is received from the SSBTN liaison and consultant.
