

November 2016 Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance - Dr. Dusty R. Johnston

- Vernon College hosted a town hall meeting for Senator Charles Perry and Representative Drew Springer on October 26 in the Osborne Auditorium on the Vernon campus. Over sixty area residents attended the event. Many issues of local importance, including community college funding, were discussed by the legislators.
- Vernon College partnered with Monica Wilkinson and Meg Heatly to write and submit an USDA grant to expand, promote, and advertise regional Farmer's Markets. The College recently received news that the grant has been awarded. Michelle Alexander is the primary contact for Vernon College as the College is the fiscal agent and the primary lead. The grant will fund three part time positions to implement the grant and accomplish the grant initiatives. The grant is \$500,000 over three years.
- The Vernon College Leadership Academy is going very well. There are eight participants that meet every other
 Friday afternoon for two hours. Three sessions have been completed and there are three more remaining. Topics
 for discussion have included
 - o Characteristics of excellent leadership
 - John Maxwell's book Leadership 101
 - "Seven Steps to Boost Your Leadership Self-Confidence" by Dr. Marshal Goldstein
 - o Mark Sanborn's book You do not have to have a Title to be a Leader
 - Self-reflection, real examples, questions, and discussion have all been important components of the sessions
 - o John Rouche's "Six Attributes of Effective Leadership"
- Vernon College Preview Day conducted on Wednesday, October 26 as specifically designed to highlight the Vernon campus to area high school students and counselors. Approximately 350 students attended from thirteen area high schools. The event included tours and information sessions and concluded with a nice outdoor lunch.
- The Campus Carry Task Force is finalizing recommendations after several months of study and discussion. The recommendations will be reviewed by the administrative team and forward to board members for final action. The task force has been extremely diligent in their efforts.

- The Student Success Data Fact presented to the **Board of Trustees** in October was the Key Performance Indicator of Accountability for Graduation, Persistence and Retention Rate. Benchmarks and data specifically related to Title III were highlighted.
- Key Performance Indicators of Accountability updates for Fall 2016 should be completed and posted to the Vernon College website by mid-November.
- o Majors and completers data disaggregation is underway for Program/Discipline Evaluation.
- o The CBM 116 Adult Learner Follow-up Report required by the Texas Higher Education Coordinating Board is in the final edit stage and should be certified by November 3rd.

- The **Student Success Data Committee** met on October 21, 2016. A primary agenda item was to review the 2015-2016 Institutional Effectiveness Plan Final Summaries in regard to assessment, assessment results and use of results for improvement.
- The College Effectiveness Committee met on October 28, 2016. - An onsite visit was held on October 24-27, 2016. This visit comprised of an initial setup and configuration of the purchasing system, testing of that setup and a "train the trainer" session.
- Those who completed the training all agreed that the new system is much easier to learn and use and should provide a better experience for all of those who will use the system.

- U4SM has installed the system on our dedicated cloud servers.
- The test environment for U4SM is being configured for Vernon College data.
- Data conversion for U4SM should begin within the next 1-3 months.
- There will be a training on November 10, 2016 for the Implementation Team with U4SM. This training will consist of a deeper dive into our specific modules that have been purchased.
- Following the training the Implementation Team will be given their logins to begin the testing and setup of the system.
