

September 2018 Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance – Dr. Dusty R. Johnston

- The Vernon College Board of Trustees approved the proposed Vernon College 2018-2019 operating budget at the August 8 meeting. The proposed budget was a result of several months of work including input from faculty, staff, administration, and board members. The Board of Trustees had reviewed the budget progress in the past four regular board meetings. The approved budget totals \$22,396,346 and is an increase of approximately \$344,291 or 1.5 % above the 2017-2018 budget. The budget includes a 1.5% increase step increase in accordance with approved salary schedules plus a 1.5% raise for a 3% total increase in compensation for all employees. The increase in the total 2018-2019 budget compared to the total 2017-2018 budget is primarily due to:
 - o 3% total salary increase for employees—approximately \$290,000
 - Proactive plan for roof repairs—approximately \$100,000
 - College van replacement—approximately \$25,000
 - o Increase management tools for Cyber-Security—approximately \$20,000
- The Vernon College Board of Trustees conducted a public meeting for discussion of tax rates on July 11, 2018. Based upon the WCAD certified appraisal data (which was a very slight increase over last year—approx. \$2 million), Vernon College published a tax notice on Thursday, August 9, 2018 stating the effective rate of 23.1469 cents per \$100 of appraised property value. This is a slight decrease from the previous year tax rate of 23.2367 cents per \$100 of appraised property value. The tax rate resolution was approved at a special meeting on August 16, 2018.
- The Fall Kick off for all employees was conducted on August 20. The agenda was very informative and the afternoon breakout sessions provided specific and pertinent information for groups of employees. The sessions conducted by Brooks Harper received very positive comments.
- The fourth offering of the Vernon College Leadership Academy for employees has twelve participants for the fall 2018semester. The academy meets for six two-hour sessions on Friday afternoons during the fall. This year's academy is also supported by Canvas online supplemental instruction. The academy covers a wide range of topics to provide leadership development as well as specific information about Texas community colleges.
