- At the meeting on July 14, the Vernon College board approved to purchase a new bus. The proposal is to keep the two current buses and to purchase one new bus to provide safe travel for all students, athletes, coaches, and employees. The board approved to purchase a 37-passenger bus from National Bus Sales via the Texas state purchasing contract for a total price of \$198,300.
- The board discussed draft four of the 2021-2022 budget. The 2021-2022 budget has undergone tremendous scrutiny the past several months. Since summer enrollment has held steady compared to last year and we are using that as a predictor for fall enrollment, the budget draft 4 includes a 1.5% salary schedule step increase and a 1.5% salary increase for a total of a 3% compensation increase for all employees. Draft 4 is based upon a conservative estimate of tuition and fee revenue with a 5% holdback since 2021-2022 enrollment is a speculative estimate at this time. Because of the "surprise" state funding, we have been able to include two additional roof replacements on the Vernon campus and fund additional improvements to instructional technology across all campuses. Draft four tax revenue is based upon the estimated effective "no new taxes" rate. Draft four includes the following expectations:
 - Conservative estimate of tuition and fee revenue
 - 1.5% salary schedule step increase in compensation for all employees
 - 1.5% additional salary increase in compensation for all employees
 - o 1 new van
 - 2 roof replacements
 - o 1 new grant writing position
 - 1 new student success specialist position to support mandatory advising (funds reallocated from one retirement and one internal transfer)
 - Increase in the number of paid faculty advisors (5 to 10)
 - Increase in faculty professional development travel
 - Increase in instructional technology
 - Increase in distance learning technology
 - o Increase in nursing testing budget to be more accurate
 - Increase in information technology equipment

- Some of the above will be possible due to reallocated HEERF funds claimed for "lost revenue" due to the impact of COVID-19 disruption
- Discussions continue with the Wichita County Commissioner's Court regarding the possibility of a branch campus maintenance tax being place on the ballot for the November 2 election. Basic information include:

✓ Purpose:

The purpose of the branch campus maintenance tax (BCMT) supported by Wichita County residents is to enable Vernon College to develop additional career and technical programs and courses to support local business and industry workforce needs. The BCMT tax revenue would also assist to sustain and enhance current operations, programs, and services including instruction, student services, fiscal operations, physical plant, maintenance, and technology at Skills Training Center, Century City Center and other Wichita County instructional sites to provide vital, accessible, and economical educational and training opportunities for Wichita County residents.

Texas' statutes permit the creation of a limited property tax to support, maintain, and operate a community college campus in locations (jurisdictions) outside of its' taxing district. Vernon College's taxing district is Wilbarger County and Texas law restricts those tax revenues to fund facilities and operations only in Wilbarger County. The branch campus maintenance tax (BCMT) may not exceed \$.05 per \$100 of assessed valuation in the jurisdiction. The current Vernon College tax rate for Wilbarger County residents is \$.2318 per \$100 of assessed valuation.

✓ Positive Impact

- Development and implementation of new Vernon College career/technical programs to train residents to meet local and regional business and industry workforce needs
- Expansion and enhancement of current Vernon College career/technical programs which train residents to meet local and regional business and industry workforce needs
- Reduction in tuition cost to Wichita County residents
 - Offset a reduction in tuition for Wichita County residents attending Century City Center, Skills Training Center, or other Vernon College Wichita County instructional sites because the BCMT code ensures they pay the same in-district tuition rate as Wilbarger County resident students
 - Currently, Wichita County residents pay \$100/Semester Credit Hour (SCH) for tuition while Wilbarger County residents pay \$60/SCH for tuition because of the Wilbarger County tax support. This would save an estimate of \$600 per semester or \$1200 per year for each full-time Wichita County student taking 15 SCH per semester.
 - Offset a reduction in tuition for all Wichita County high school students in dual credit academic, technical, or Early College High School classes to ensure they pay the same in-district tuition rate as Wilbarger County resident students.
 - Vernon College currently charges \$0 tuition to in-district high school dual credit students
 - This would create various savings for the Wichita County ISDs
- Sustain and enhance current operations, programs, and services including instruction, student services, physical plant, maintenance, and technology at Skills Training Center, Century City Center and other Wichita County instructional sites to provide vital, accessible, and economical educational and training opportunities for Wichita County residents.

College Effectiveness – Betsy Harkey

To ensure access to all constituents the questionnaire link will be posted on the VC website, shared via social media, posted in CANVAS, and emailed to selected lists of students and other VC constituents. This process is designed as a wonderful opportunity to gather information and input from VC constituents.
- SACSCOC Substantive change approval for Surgical Technology was received in late July. The document was submitted in January 2021. This change was the for the deactivation of the Surgical Technology Certificate of Completion due to the National Board of Surgical Technology and Surgical Assisting stating that students will no longer have the option of the Certificate of Completion for Surgical Technology. Students must successfully complete the Associate of Applied Science degree requirements to be eligible to complete the program and sit for the national Certified Surgical Technology (CST) credentialing exam.
