

# April 2022 Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

## College Governance - Dr. Dusty R. Johnston, President

- Board of Trustee Election-- When there is an unopposed election; the governing board must meet, accept a *Certification of Unopposed Candidates* and issue an *Order of Cancellation* declaring the election cancelled and the unopposed candidates elected. The *Order of Cancellation* must then be posted on Election Day at each polling place. The board approved these at the March 9 meeting. Betsy Smith and Jamie Chapman will retain their places on the board while Meg Heatly will be the new board member filling the place vacated by Todd Smith. All three newly elected members will be certified at the May 11 board meeting. That will be Meg Heatly's first meeting. Dr. Smith will appoint a nominating committee at the April 13 meeting and new board officers will be elected at the May 11 meeting after the three members are certified. Dr. Smith's last meeting will be April 13.
- Skills Training Center lease—The board approved a new amendment to the Skills Training Center lease. The term of the lease is January 1, 2022 thru December 31, 2029 (7-year lease). Approximately 50,000 square feet at \$2.05/sq. ft. totally \$102,500 per year paid monthly at a rate of \$8541.67. This is slightly lower than the rate the past five years, which totaled \$104,000 per year. This is a very good rate per square foot comparable to the market in Wichita County.
- Audit-- The College must be audited each year by an independent auditor. The Board of Trustees must approve in a public meeting the choice of an independent auditor to conduct the audit. Since *Edgin, Parkman, Fleming, and Fleming, PC* informed the college the company would no longer conduct college audits, Vernon College issued a Request for Proposals (RFP) to conduct the audit for the year ending August 31, 2022. Two companies responded to the RFP. The board approved *Condley and Company, LLP*. The company conducts audits with other Texas community colleges similar to Vernon College. The total proposed cost of the audit including the audit of Vernon College and the audit of Vernon College Foundation, Inc., a component unit, is \$52,000 plus actual travel expenses. The most recent audit cost \$48,500.
