

March 2024 Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance - Dr. Dusty R. Johnston, President

- Enrollment—the spring 2024 report indicates the same enrollment as last spring 2023. Enrollment this spring is 1990 students which was the same enrollment as last spring. I hope this means the Vernon College has stabilized and that 2024 fall enrollment will show increase. Vernon College employees are exploring all options to turn the enrollment issue around to positive increases for the 2024-2025 school year.
- The Vernon College Board of Trustees approved the following at the February 14 meeting:
 - Auditor The College must be audited each year by an independent auditor. The Board of Trustees must approve in a public meeting the choice of an independent auditor to conduct the audit. The board approved a proposal of services from *Condley and Company, LLP* to conduct the audit for the year ending August 31, 2024. The total proposed cost of the audit including the audit of Vernon College and the audit of Vernon College Foundation, Inc., a component unit, is \$57,500 plus actual travel expenses. The most recent audit cost \$54,300. Condley and Company, LLC has done an excellent job the past two years.
 - Room and Board rates—Each year the Board of Trustees reviews the room and meal plan rates to be charged in the upcoming year. The current room and board rate is \$2498 for the fall semester and \$2524 for the spring semester. Vernon College has not increased the room rate (\$500/semester) in several years and a room rate increase was not proposed for 2024-2025. Meals are not provided to summer school students who live in campus housing and there is no proposed increase in summer room rates, which are currently \$200 per person each summer session. During the fall and spring semesters, each student who lives in the residence hall must also purchase a meal plan. The meal plan proposal has increased a small amount due to increased food and personnel cost for Great Western Dining. Great Western Dining proposed an increase of approximately 3.2% for the 2024-2025 school year for the meals provided in the residence hall students as part of room and meal plan costs primarily due to increased food costs. The board approved the following rates for 2024-2025:

Fall \$500 room \$2078 meal plan (77 days) \$2578 total room and meal plan Spring \$500 room \$2105 meal plan (78 days) \$2605 total room and meal plan no meal plan

- ^o Tuition and Fees for 2024-2025—due to the many variables negatively influencing enrollment, one being financial barriers, the administrative team recommended no increases in tuition and fee costs. This will be the third consecutive year that Vernon College has not increased tuition and fees.
- Academic Calendar— each spring the calendar committee works with faculty, staff, and administration to develop an effective yearly academic calendar. The calendar takes into consideration Texas Higher Education Coordinating Board guidelines and reporting deadlines, area high school calendars, Midwestern State University calendar, program needs/requirements, registration needs, and final exam needs. The board approves the academic calendar annually.
- Medical Assisting program- The Medical Assisting program, located at Century City Center, was last offered during the 2022-2023 academic year with 6 students. In May 2023, the full-time instructor decided to resign. With the previous low enrollment, lack of full-time instructor, and budget constraints at the time, Vernon College made the decision to not offer the program during the 2023-2024. The board approved the recommendation that the program be officially closed as a credit program and be added as an approved continuing education program in the near future. This has been approved by the Vernon College Academic Council and College Effectiveness committees. The board must approve the program closure so we can notify SACSCOC of the program closure. This is an action item.
- Employee Retention Credit (ERC)--the ERC is a refundable payroll tax credit that the government enacted in response to Covid-19. The ERC is calculated based on qualified wages paid during a period of eligibility. College employees have been working several months with a company that specializes helping entities claim appropriate ERC. Vernon College will submit a claim based on eligibility and certain criteria. If the application is approved, Vernon College will receive funds from the IRS.
- ° City of Vernon property easement--there is an existing water line from a meter on Augustus Street that runs across Vernon College property beside the Bi-Fork building that needs repair/replacement. The water line

- feeds the Hillcrest Country Club. The City of Vernon and the Hillcrest Country Club have agreed on moving the meter and replacing the water line, but it will run across Vernon College property. This formal easement will allow the city to replace and maintain the water line.
- ° The Vernon College Board of Trustees conducted the annual evaluation of the president in a closed executive session. Based upon a positive evaluation the president's current contract was extended for one year.
