

August Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

College Governance – Dr. Dusty R. Johnston

- The Vernon College Board of Trustees approved to call a special election to fill the current board vacancy. Filing packets for potential candidates have been available since Tuesday, August 3. The last day for a candidate to file for the seat is Tuesday, August 24. The election will coincide with other elections in Wilbarger County on Tuesday, November 2. The candidate must reside in Wilbarger County.
- The board has reviewed the timeline for the financing of revenue bonds to provide \$5 million of funds for renovation of Century City Center. The process should be complete by the end of September. We all have a lot of work to do in the next few months to finalize renovation plans to meet the many needs of students, programs, and employees at Century City Center.
- Purchasing guidelines, meal reimbursement guidelines, and mileage reimbursement guidelines have been updated and clarified for all employees. Please see the attachments.
- Bids for phase one of the baseball field expansion and renovation project have been approved. Santa Rosa Construction is the Construction Manager at Risk. Renovation should begin the first part of August. The cost of phase one is \$712,394 with \$500,000 coming from a generous donor. The additional funds will not come from any specific department budget, but will come from tuition and fees revenues that have been higher than 2009-2010 budget estimates.
- Renovation efforts at Skills Training Center are moving at a brisk pace. The enhancements will benefit all programs and especially the students.
- House Bill 1568 from the last legislative session gave community colleges the authority to provide tuition
 exemptions for employees. The board has directed the administrative team to develop guidelines for such
 exemptions. If approved at a later meeting, the tuition exemptions would go into effect for the 2011 spring
 semester.
- The fall 2010 back to school kick-off is Monday, August 16. The speaker, Paul Vitale, is exceptional. The morning will be extremely worthwhile for all employees. Please see the attachment.
- The Retention/Completion Task Force is being finalized. This task force will be charged with recommending improvements to current processes and new processes to implement which will improve our student retention and completion rates.
