

# February Update

This monthly report is intended to provide the Vernon College Board of Trustees, Vernon College Foundation Board members, as well as college faculty and staff, with updated information regarding significant college activities, issues, and accomplishments.

#### College Governance – Dr. Dusty R. Johnston

• As the legislative appropriations process has begun, there has been a wide array of discussion about HB 1 and SB 1 and the impact on community colleges and especially the direct impact on Vernon College. After being in Austin for several days, I am certain that everything is still up for discussion, but there will be significant reductions to all state agencies. A summary of significant reductions to all community colleges includes:

	HB 1	SB 1
Instructional formula funds	-7.7%	-10.5%
Small school supplement	-6.9%	-9.7%
Group health insurance	-82.3%	-38.6%
Retirement funds	-44.2%	-43.0%

Both bills include no funding for enrollment growth which is estimated at 21.7% for all community colleges. A specific picture of this impact is that at the beginning of the 2010-2011 biennium, the average contact hour funding was \$7.11. After the reductions during the biennium, the average contact hour funding became \$6.55. In the current proposed budgets, the average contact hour funding in HB 1 is \$5.55 and \$5.39 in SB 1. As these proposed reductions in appropriations become reality, each institution will have to make hard decisions in regard to budget reductions and possible tuition, fee, and tax increases.

The specific impact to Vernon College, based on the HB 1 and SB 1 proposals, is a reduction in current funding ranging from \$750,000 to \$1.1 million per year. A key point is that this is in addition to the current biennium reductions which totaled \$823,377 over the two years of the biennium. The current Vernon College budget continues to be scrutinized for reductions as we begin the budgeting process. Tuition and fee increase proposals continue to be evaluated as well as the College works to move forward as we absorb these state appropriation reductions.

The Texas Association of Community Colleges and the Texas Community College Teachers Association have taken a very strong stand on all reductions, but are especially emphasizing the concerns in regard to group health insurance funding and retirement program funding.

- The planning cycle is really beginning to gel at Vernon College. Everyone is working hard to produce solid plans for the different components of the College. College faculty and staff are currently working toward accomplishing plans that we developed last spring for the 2010-2011 annual action plan. We will also finalize plans in February that will produce the 2011-2012 annual action plan. At the end of the semester and into the summer, we will be working to finalize the 2010-2011 annual action plan by assessing what has been accomplished during the year toward meeting annual action plan expectations. A primary point is that the annual action plan we produce for 2011-2012 will be important as we begin to develop the budget for 2011-2012.
- Construction and renovation projects are moving along very well. The Skills Training Center renovation is 99% complete. Two punch lists were done in December and January and all of the little things are being followed-up on and completed. It is a very impressive renovation. The Police Academy and criminal justice program has relocated to the facility. Classes are being conducted. Leadership Wichita Falls was the first group to use the new multi-purpose conference room. The baseball field renovation/expansion is moving along well. It is approximately 80% complete as we are getting into the smaller parts of the construction. The project manager assures us that we will meet our expected deadline for completion which is February 15. Rick Sims and his crew are working hard on the schematic, blueprints, and specs for the Century City Center renovation. We are watching the timeline that he handed out at the December meeting. Bids should be accomplished in May and construction should start in early June.
- The college effectiveness committee, Betsy Harkey, and I have been working on the Key Performance Indicators of Accountability (KPIAs) for over a year. The goal is a clear presentation of data that represent key performance

indicators of accountability or key measures that tell the story of how well we are doing as a College. A presentation of the KPIAs was made to all employees on January 10 and another presentation was made to board members at the January 19 board meeting. This data will continue to be very important as we tell the success story of Vernon College students. The need for this type of data and the use of this data for improvement was highlighted at the Texas Community College Administrators and Trustees conference this past month in Austin.

Additionally, of the 50+ public institutions in Texas offering LVN programs, only 6 graduated more students than did Vernon College in 2010. Congratulations to Director Lynn Kalski and LVN faculty members Mary Jane Batchelor, Marla Divine, Sue Fitzwater, Zela Haney, Tom Hickey, Kathy Nault, Rilda Novak, Dennis Peterson, Della Porter, Pam Rotz, and Cassie Shaw for a job well done!
