The Transportation Industry is growing and there is a high demand for well-trained drivers. This five-week course utilizes state-of-the-art simulator training, classroom instruction, range and road driving, and practical application of skills used in the operation of a tractor-trailer. The truck-driving course prepares students to complete the written exams and the driving exam necessary to receive a Class A Commercial Driver's License (CDL). The course meets all Federal Motor Carrier Safety Administration guidelines. Students who successfully complete the entire course will receive a class "A" Commercial Driver License, a certificate of completion and be qualified to secure an entry-level job as a Commercial Motor Vehicle driver.

Registration:

- A student may enroll in an upcoming Truck Driving course to reserve their seat.
- **Payment for FULL tuition or proof of funding is required upon registration.**
- Student must be 18 years of age at the commencement of the course.
- Copy of the students valid/current Drivers License is required at registration.

Requirements Prior to the Start of Class:

1. Student is required to have a DOT physical (Department of Transportation Medical Card) and clean drug screen completed prior to class. Cost of the physical and drug screen is not included. ***Please note that per federal guidelines, drug screen results must be within 30 days of the start of class.*** The following link explains the physical qualifications for a Commercial Motor Vehicle (CMV) driver: [Click here for Physical Qualifications](#).
2. Student must also have a copy of a driving record obtained through the Texas DPS office with 3 years of driving history.

4. Students MUST bring all documents to the first day of class.
